

TERMS AND CONDITIONS
The Olde Field Flower Farm
2018 Season

Policy: I understand that payment for my “CSA” share(s) is due in full at the time of enrollment. And, that once I have joined and paid for my share(s), I have secured my membership for the respective season in its entirety. There are no refunds, either full or partial, for cancellation of my membership once purchased. I may, however, transfer my share(s) to another individual. I understand that “CSA” will not issue any refunds to me, either full or partial, for any share(s) transferred. Should I decide to transfer my share(s), it is my responsibility to provide “CSA” with the name of the transferee. It will then be the responsibility of “CSA” to provide the transferee with any remaining share(s) under the terms of this agreement.

The “CSA” Season: I understand that the start of each flower season can vary based on seasonal conditions and product availability. I am aware that “CSA” will communicate via e-mail/text to inform the members of the season’s anticipated start date and all bouquet pick up dates as well as any updates relating to the season and harvest. I further understand that it is my responsibility to contact “CSA” if I have not received an e-mail/text regarding the start of the season by June 15, 2018.

Pick Up of Seasonal Share: I understand that I am to pick up my seasonal stems at Thayer Nursery, 270 Hillside Street, Milton. The pickup dates will be scheduled at the beginning of each month at the discretion of the farmer and based on harvest conditions. I further understand that it is my responsibility to pick up my stems on all designated pickup days. The farmer encourages all “CSA” members to make every effort possible to pick up their seasonal stems and agrees to release stems to any third party designated by the “CSA” member. I understand that I will not receive any credits or refunds for any stems that I do not pick up and that such stems will be donated at the sole discretion of the farmer.

Sharing the Season: I understand that as a “CSA” member, I share in both the rewards and the risks of farming. I understand that these risks include poor harvests, or no harvest, resulting from unfavorable weather conditions or pests, or a total loss of all crops due to a natural disaster such as fire, flood, drought, tropical storm or hurricane.

Flower Care: I understand that all seasonal stems are available for pick up within twenty-four (24) hours of each harvest and that all flower varieties are perishable and have a variable vase life. I further understand that the farmer is not responsible for any stems left at the farm for more than twenty-four (24) hours after scheduled pickup.

Communication: I understand that, upon joining the “CSA,” I will provide my correct e-mail address and will be added to the “CSA” weekly e-mail/text list. I further agree to add **oldefieldflowerfarm@gmail.com** to my email contacts. I understand that “CSA” will not be held responsible for miscommunications as a result of e-mails routed to a spam folder. I will notify the “CSA” immediately if I do not receive either my e-mail receipt for payment or any weekly “CSA” e-mail.
